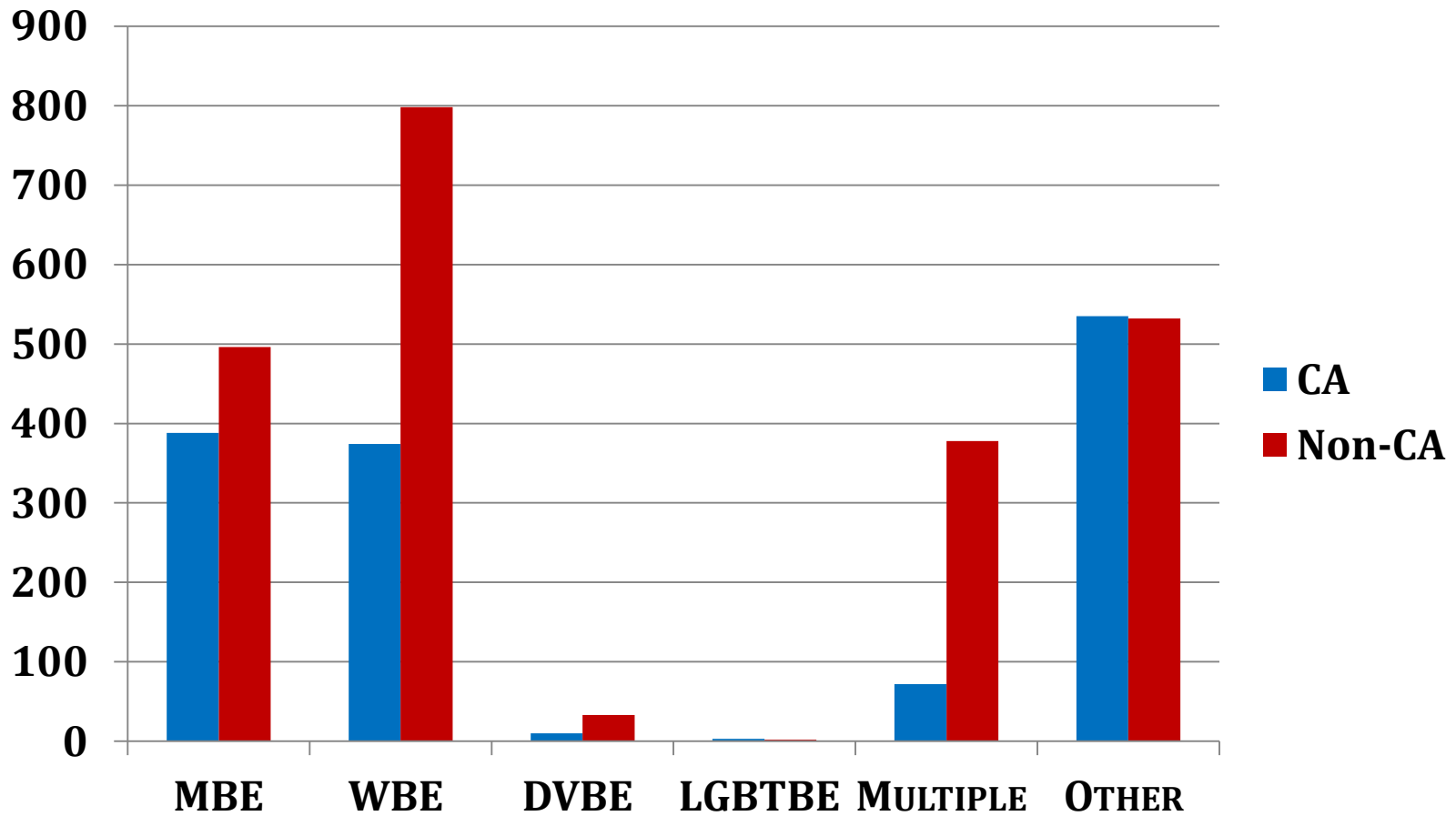

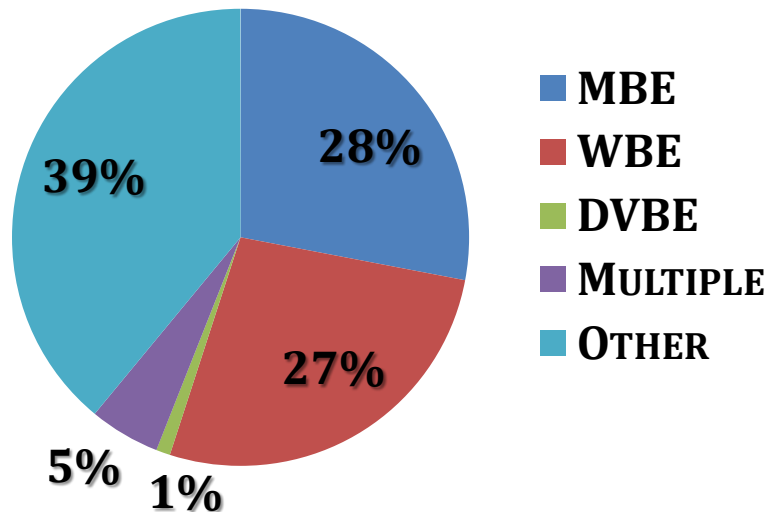
PROCUREMENT BY: **TYPES OF CERTIFICATION** **(# OF CONTRACTS)**



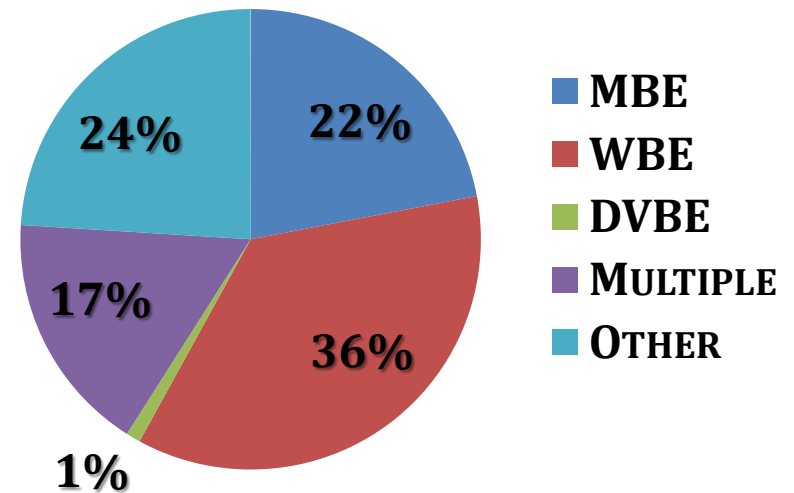


PROCUREMENT BY: TYPES OF CERTIFICATION (# OF CONTRACTS)

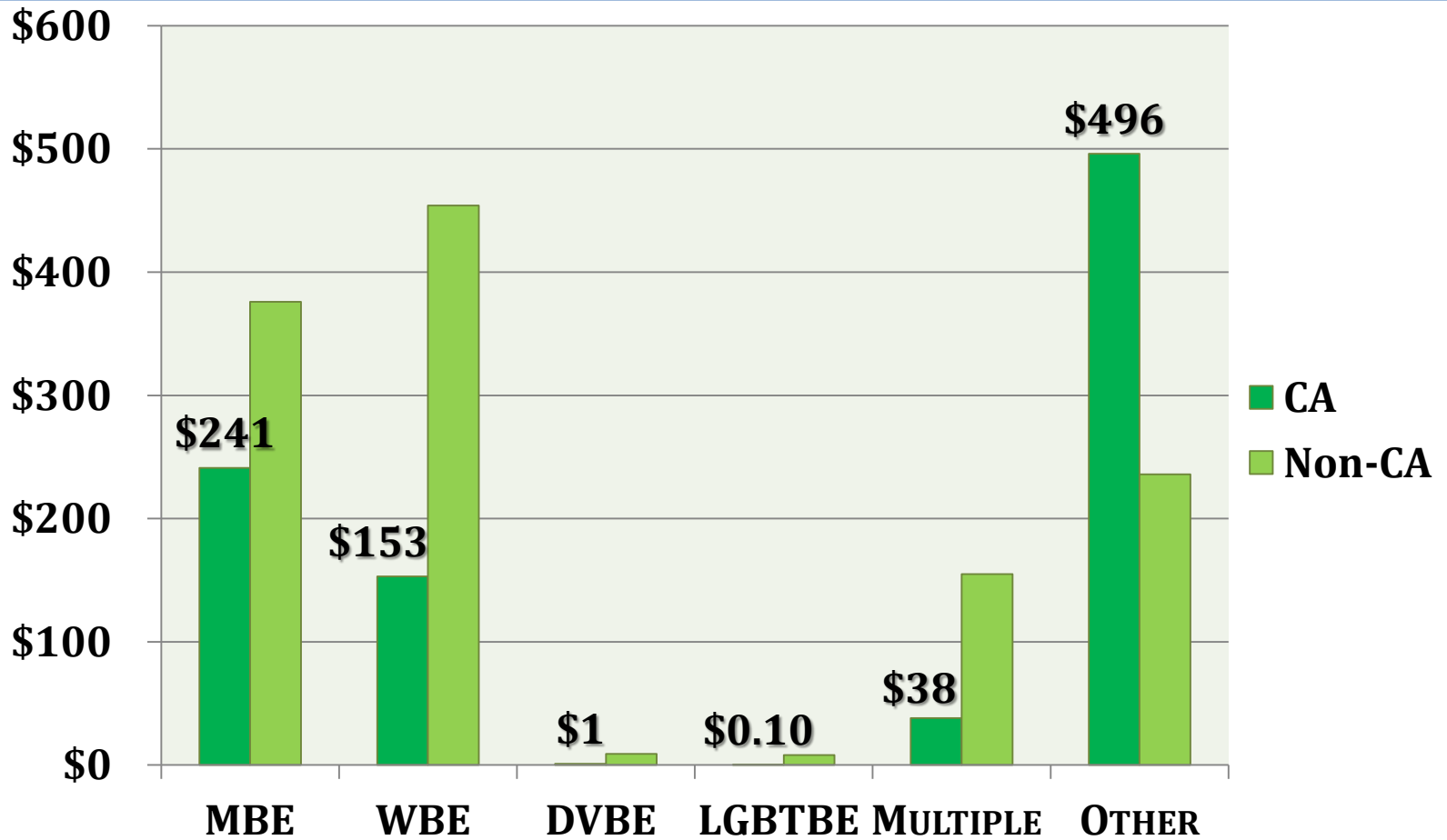

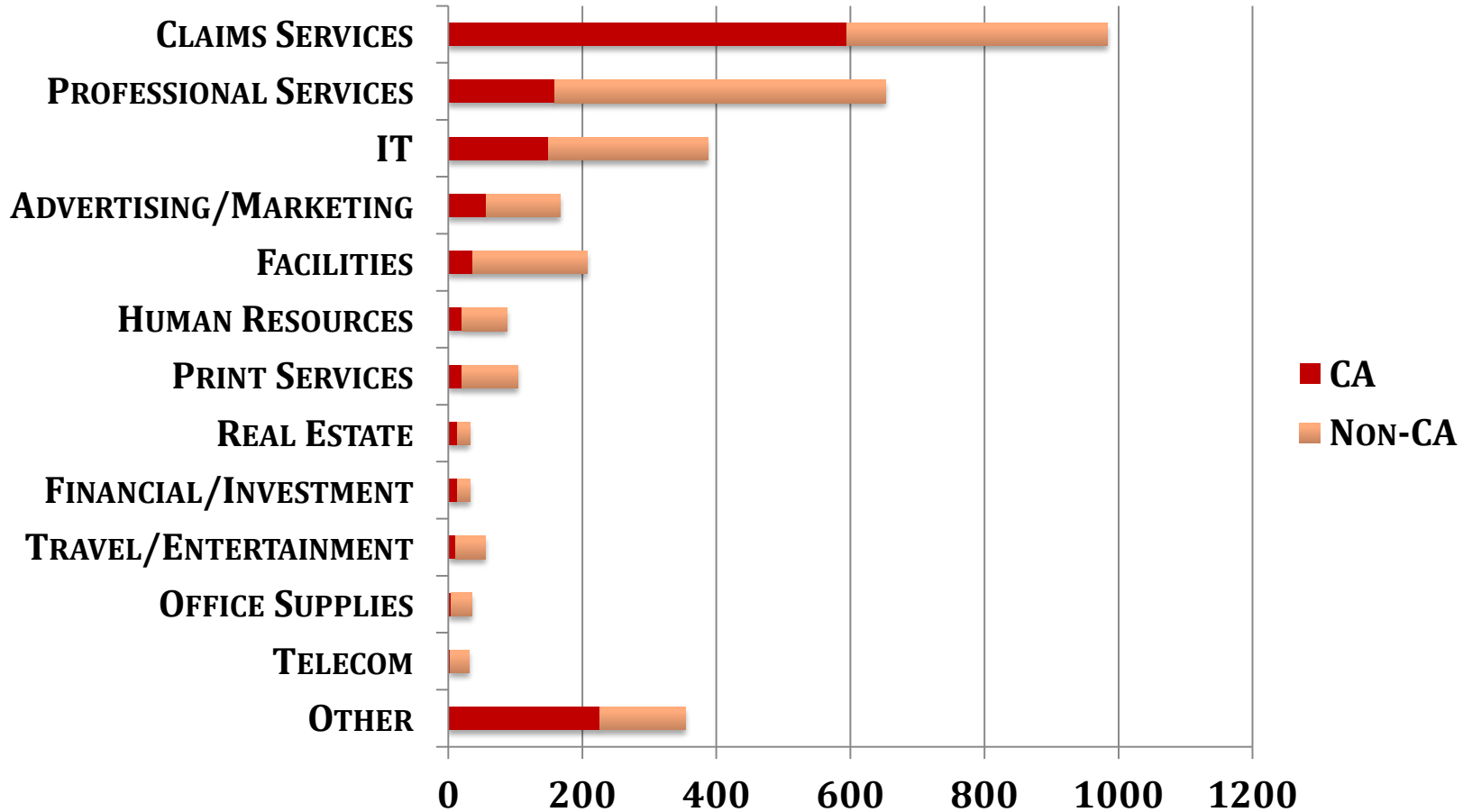

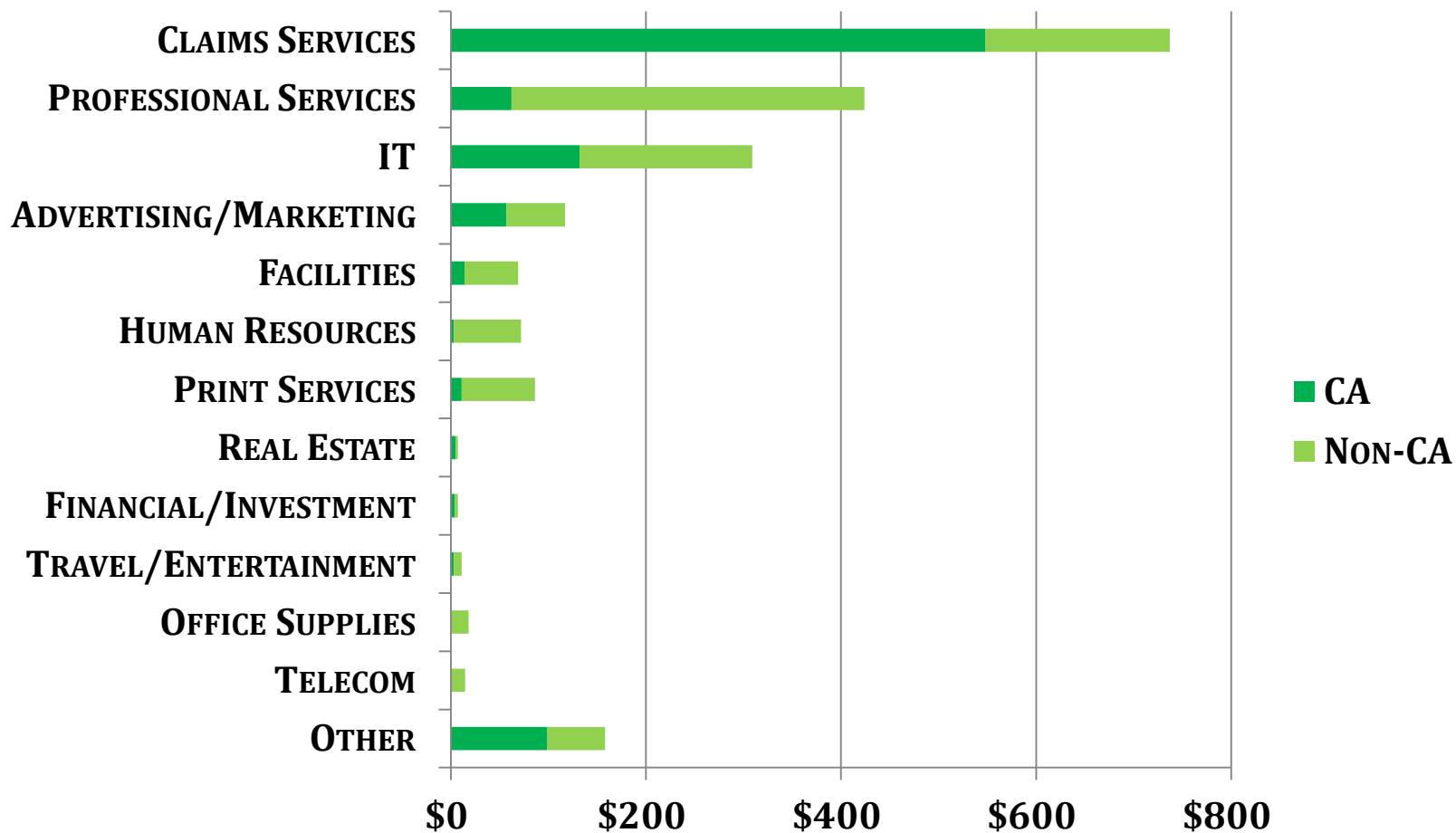

(\$ OF CONTRACTS)



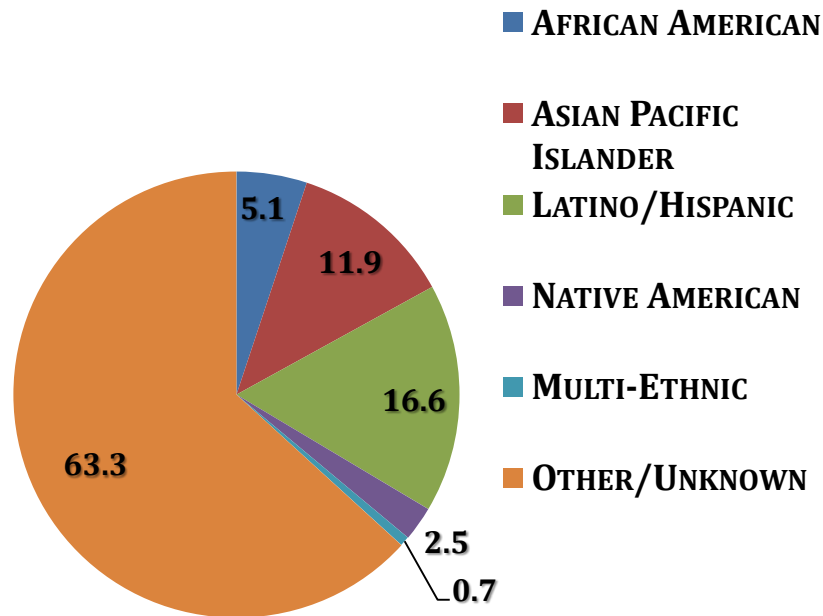

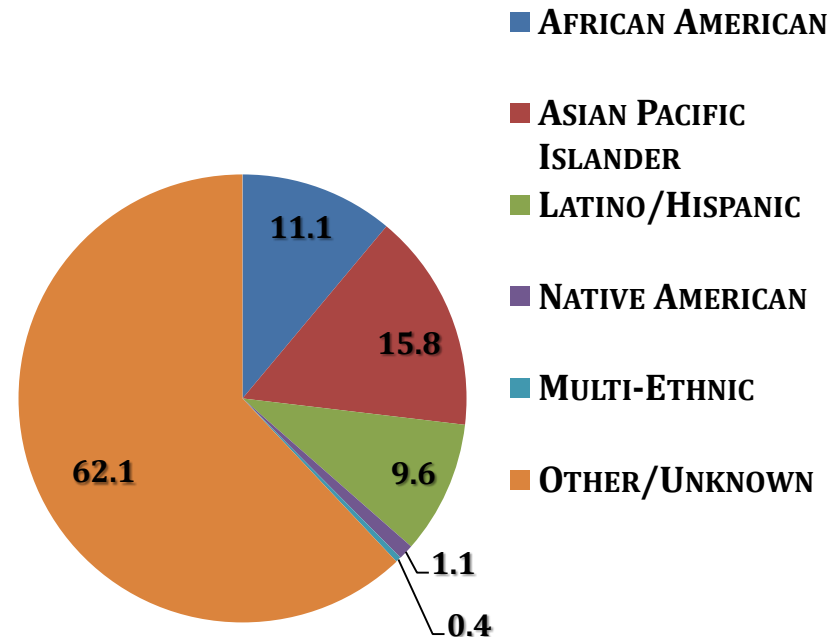
